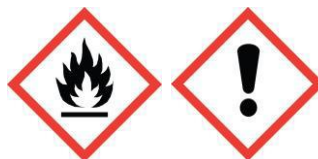

4. First aid measures

4.1. Description of first aid measures

General	Move victim to fresh air. Call 911 or emergency medical service if deemed necessary. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult.
